TOTAL OF \$1,164,808.07 FOR CO-OP AGREEMENT DEMANDS, CHECK NUMBERS 1132 THROUGH 1135, WHICH ARE COSTS ASSOCIATED WITH THE CONSTRUCTION OF CAPITAL PROJECTS WITHIN THE FORMER REDEVELOPMENT PROJECT AREA, USING BOND PROCEEDS TRANSFERRED FROM THE SUCCESOR AGENCY TO THE CITY.
