**IV. BACKGROUND**

Section 2403(A) of the Carson Municipal Code (CMC) provides, in part, the regular meetings of the City Council shall be held on the first and third Tuesdays of each month at the hour of 5:00 P.M. If any such day is on a holiday, then the meeting shall be held on the next succeeding day of which is not a holiday.

It has been the accepted policy of the Mayor and City Council to reschedule meetings to another date to accommodate their schedules. The past practice of the Mayor and City Council has been to reschedule the regular meeting to the following Wednesday in most instances.
