City of Carson reserve funds: \$32,894,981.82 City of Carson cash revenue: \$11,403,867.09

City of Carson Successor Agency reserve funds: \$14,737,971.83 City of Carson Successor Agency cash revenue: \$922,020.74

City of Carson Successor Agency bond funds reserves: \$1,979,928.20

City of Carson Housing Authority reserve funds: \$716,837.98 City of Carson Housing Authority cash revenue: \$716,837.98

City of Carson Housing Authority Bond Funds reserves \$5,877,496.55
