Submitted for Council's review is the monthly Investment and Cash Report for the City of Carson, Successor Agency and Carson Housing Authority for the month ending April 30, 2018. Following are the total reserve and cash amounts for each Carson entity:

City of Carson reserve revenue: \$36,949,118.51 City of Carson cash revenue: \$10,105,381.13

City of Carson Successor Agency reserve revenue: \$12,563,158.95

City of Carson Successor Agency cash revenue: \$ 363,522.19

City of Carson Successor Agency bond fund reserves: \$1,850,507.16

City of Carson Housing Authority reserve revenue: \$554,743.12 City of Carson Housing Authority cash revenue: \$807,936.17

City of Carson Housing Authority bond fund reserves \$3,087,142.46

The City has the ability to meet its expenditure requirement for 6 months and beyond. All investments are in compliance with state code 503600, City of Carson investment policy and all applicable bond indentures.
