City of Carson reserve revenue: \$41,256,058.49

City of Carson cash revenue: \$ 5,422,420.26

City of Carson Successor Agency reserve revenue: \$10,953,827.74

City of Carson Successor Agency cash revenue: \$ 263,178.74

City of Carson Housing Authority reserve revenue: \$555,678.44

City of Carson Housing Authority cash revenue: \$ 255,814.57

City of Carson Housing Authority bond fund reserves \$3,097,751.04

The monthly Investment and cash Report is submitted to the Mayor and City Council to ensure that the legislative body is kept abreast of the value of the reserve funds and available cash for each Carson entity. The City has the ability to meet its expenditure requirement for 6 months and beyond. All investments are in compliance with state code 503600, City of Carson investment policy and all applicable bond indentures.
