Submitted for Council's review is the monthly Investment and Cash Report for the City of Carson, former Carson Successor Agency and Carson Housing Authority for the month ending November 30, 2018. Following are the total reserve and cash amounts for each Carson entity:

City of Carson reserve revenue: \$37,574,114.44

City of Carson cash revenue: \$ 8,009,980.40

City of Carson Successor Agency reserve revenue: \$11,270,367.07

City of Carson Successor Agency cash revenue: \$ 275,528.54

City of Carson Housing Authority reserve revenue: \$ 40,412.19

City of Carson Housing Authority cash revenue: \$ 64,701.52

City of Carson Housing Authority bond fund reserves \$ 3,102,797.39
