City of Carson reserve revenue: \$37,574,114.44 City of Carson cash revenue: \$8,009,980.40

City of Carson Successor Agency reserve revenue: \$11,270,367.07 City of Carson Successor Agency cash revenue: \$275,528.54

City of Carson Housing Authority reserve revenue: \$40,412.19 City of Carson Housing Authority cash revenue: \$64,701.52

City of Carson Housing Authority bond fund reserves \$ 3,102,797.39
