City of Carson Housing Authority cash revenue: \$890,124.55

City of Carson Housing Authority bond fund reserves \$3,114,251.38

The monthly investment and cash report is submitted to the Mayor and City Council to ensure the legislative body is kept abreast of the value of the reserve funds and available cash for each Carson entity. The report covers the reserve funds for the City of Carson, Carson Successor Agency and the Carson Housing Authority.

The city has the ability to meet its expenditure requirement for 6 months and beyond. All investments are in compliance with state of California code section 503600; the Carson investment policy and all applicable bond indentures.
