**\*\*City of Carson cash revenue: \$20,061,639.17**

City of Carson Successor Agency reserve revenue: **\$8,228,119.35**

City of Carson Successor Agency cash revenue: **\$2,414,025.73**

City of Carson Housing Authority cash revenue: **\$3,383,041.55**
