At this time, Staff is proposing an amended and updated job spec to properly reflect current City needs for the Buyer role in the Finance Department.

A vacancy exists in the Finance Department as a result of an employee separation. This role assists in the purchase of equipment, materials and services and performs a variety of responsible duties including analyzes and edits requisitions and writes specifications, prepares invitations for bid and request for proposals, obtains bids and examines bids for conformance among other duties. The recruitment to fill the vacancy for the Buyer is underway.

The City completed the Meet & Confer on March 29, 2021 with AFSCME Local 809 and both parties are in agreement with the updated job specification.
