IV. BACKGROUND

A vacancy exists in the City Clerk Office as a result of an employee resignation. This role manages the day-to-day office services and operations of the City Clerk’s office, provides specialized technical, administrative and professional assistance to the City Clerk, supervises and evaluates the performance of assigned staff; and performs the duties of the City Clerk in the Clerk’s absence or as assigned as defined by California Statutes and the Carson Municipal Code.

The recruitment to fill the vacancy for the Chief Deputy City Clerk was initiated in January 2021. The role is at-will and unrepresented, thus there was no Meet & Confer requirement.
