This vacancy exists as a result of an internal promotion within the Division. The Human Services Department is responsible for creating programming that is safe and appropriate for our City residents. They have provided feedback that the duties are broader and include working with a variety of people, not just seniors. Social Services more accurately reflects the duties of this position, as it may include Stroke Center, Special Interest Classes, Cultural Arts programs, and more. Staff completed the Meet & Confer with AFSCME 809 on April 6, 2021 and both parties are in agreement on the proposed Social Services Coordinator job series job specs.
