## Report to Mayor and City Council

### SUBJECT:

### COVID-19 UPDATE (CITY COUNCIL)

#### I. SUMMARY

During this unprecedented pandemic, the City of Carson has had to adhere to Federal, State and County Executive orders, which initially helped slow the spread of the virus but it did so by shutting down our local businesses and severely impacting our economy. Our residents and businesses were directed by the State to follow stay-at-home orders, with the exception of employees who were determined to have an essential job or for residents to shop for essential needs. For the first time in its incorporated history, the City was not allowed to operate in any capacity outside of health measures dictated by the Federal, State and County governments.

As of the preparation of this report on April 28, 2021, Los Angeles County Public Health Department has reported 9,618 confirmed cases of COVID-19 within the City of Carson, with 1,232,079 cases within Los Angeles County (which includes cases reported by the Long Beach and Pasadena Health Departments). This underreports the actual spread of the virus since those who do not display symptoms or are otherwise mildly impacted have not been tested.

### **IV. BACKGROUND**

On March 31, 2021, the State of California moved to the Orange tier and on April 5, 2021, Los Angeles County aligned to Orange tier protocols.

As of the date of this report, Los Angeles County has reported that 6,641,945 total vaccines doses have been administered with 2,387,945 second doses. In the City of Carson, 51.1% of residents 16 and over have received at least one vaccine dose.

On April 27, 2021, the Centers for Disease Control and Prevention (CDC) released new recommendations on the wearing of outdoor masks for vaccinated individuals. The CDC now says that vaccinated individuals “can gather or conduct activities outdoors without wearing a mask except in certain crowded settings and venues.” The State of California and County of Los Angeles followed with statements saying the state and county will update their health orders to align with the CDC recommendation. While it is legally enforceable for the City to have more stringent requirements on masks, the City Council can also consider directing staff to revise the Carson Municipal Code 3708.1 Face Masks and Coverings Related to Covid-19 to conform to changes once made on the State and County levels. In the meantime, enforcement of the City’s Municipal Code will continue.

#### **Vaccine Distribution Sites in Carson**

On February 15, 2021 through February 19, 2021, Dignity Health operated a vaccination site at the Dignity Health Sports Park for City of Carson residents and others by way of appointment only. This vaccination event, held that week from 8:30am to 4:30pm, vaccinated 4,000 people a day for a total of 20,000 people. The site reopened from March 15 - 19 to distribute the required second shot only for those who received the 1<sup>st</sup> shot previously at that location.

On February 25, 2021 the City of Carson in collaboration with Carson Pharmacy, provided a “Pop-Up” Covid-19 vaccination site that administered 225 vaccines for Carson residents who are 65 years of age and older. Due to the success of the “Pop-Up” vaccination site, the City and Carson Pharmacy have continued to collaborate with additional clinics held on March 18, April 1, 8, and 27. Effective April 20th, the City of Carson in collaboration with Carson Pharmacy is providing a “Pop-Up” Covid-19 vaccination site every Tuesday and Thursday of each month for the remainder of 2021.

On April 10, 2021, the City of Carson in collaboration with CARE Ambulance provided a

“Pop-Up” Covid-19 vaccination site at the Community Center that administered 500 vaccines for Carson residents.

On April 14<sup>th</sup>, the City of Carson in collaboration with Behavioral Health Services, Inc. provided a “Pop-Up” Covid-19 vaccination site at Veterans’ Sports Complex with 1,000 Moderna vaccines administered.

On April 14<sup>th</sup> and 15<sup>th</sup>, 2021, the City of Carson in collaboration with Tri-State Community Healthcare provided a “Pop-Up” Covid-19 vaccination site at Stevenson Park with 150 vaccines administered on each day.

On April 21<sup>st</sup> and 22<sup>nd</sup>, 2021, the City of Carson in collaboration with Tri-State Community Healthcare provided a “Pop-Up” Covid-19 vaccination site for a second week at Stevenson Park with 300 vaccines administered each day.

### **Small Business Programs**

The City of Carson, in partnership with the California Community Economic Development Association (CCEDA), launched the Carson Small Business Coronavirus Business Assistance Program to provide support for small business impacted by the COVID-19 virus and associated restrictions. The program has provided technical assistance to businesses seeking Emergency Injury Disaster Loans (EIDL), Paycheck Protection Program (PPP) funding (now ended), other loan programs as well as general business assistance in managing this crisis. To date, \$6,300,000.00 in Federal Loans have been received with assistance from the City. Businesses in Carson were eligible for emergency loans of up to \$30,000 from the City of Carson’s own Loan Program funded with \$500,000. The City Council increased the Loan Program amount to \$650,000 with a total of \$650,000 being fully funded.

### **City Rental Assistance Program**

The City of Carson has created a one-time Emergency Rental Assistance (ERA) for individuals and families renting in Carson and financially impacted by the COVID-19 pandemic. The City has awarded \$156,000 out of \$179,000 total.

The financial assistance is available for up to a maximum of \$10,000 per qualified households, is based on actual need for monthly rent payment and does not have to be repaid.

### **City Hall**

City Hall is operating on Safer Hours and open to public by appointment on Mondays and Thursdays from 7 AM to 6 PM. The public is encouraged to utilize online and telephonic services as much as possible. As of the preparation of this report, the City will continue to monitor its operating hours based on Public Health Guidelines in concert with Tier status. Appointments to City Hall continue to average around 60 per week.

## **Parks**

Parks are open for active recreation such as field use and fitness classes for both outdoors and indoors (at limited capacity). A face-covering and social distancing is required. Outdoor park restrooms are open during operating hours. Tennis courts are open for individuals or members of a single household (face-covering required) and basketball courts are open for non-competitive use.

## **Recreation Programs**

Pursuant to the most recent State and County health orders, all Youth and Adult Outdoor Recreational Sports are opened with active registrations for T-Ball, Softball and Baseball.

## **Kids Club/Licensed Childcare Programs**

Per earlier guidance provided by State and County authorities, the City has reopened and is operating a number of our kids programs, namely Kids Club/Licensed Childcare programs at our parks.

Currently staff is recruiting Part-Time employees for Summer Camp. Staff also is currently recruiting for the upcoming aquatic season.

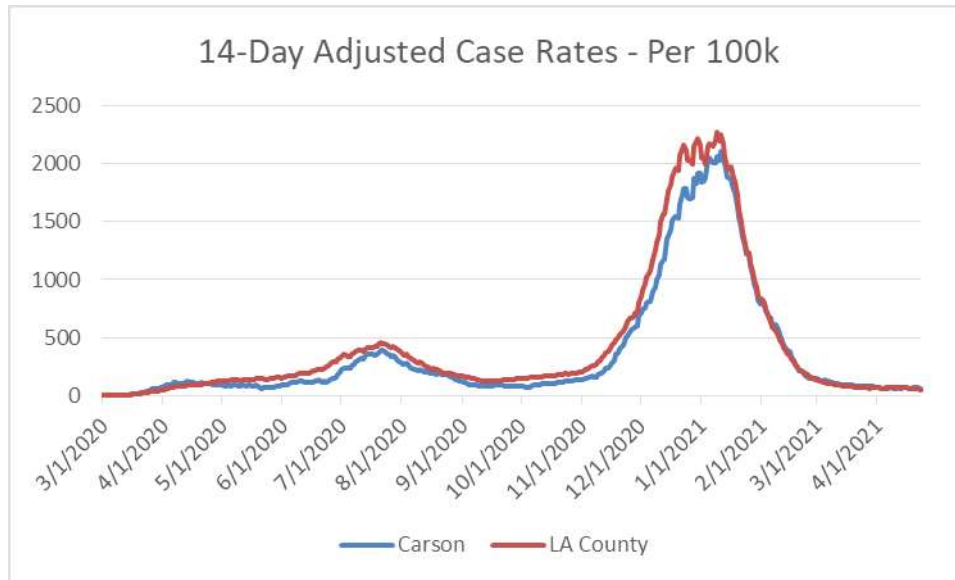

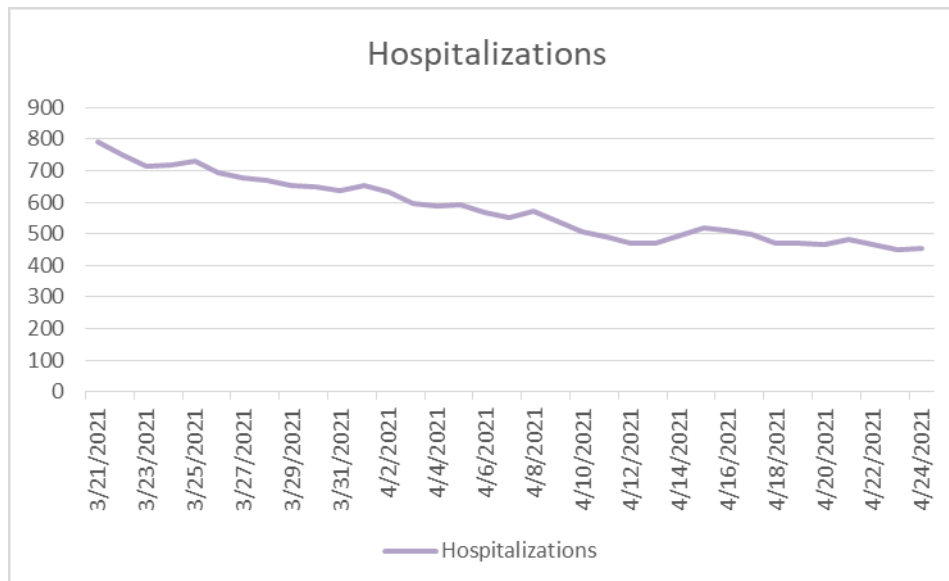

### **Carson and Los Angeles County Cases per 100K**

Current reports have indicated a stabilization of the number of positive COVID-19 cases. We want to provide a note of caution, however, that there are now a number of variants to the virus circulating that have higher transmission rates than the earlier form of the virus. There is concern that this could result in another increase in positive cases.

### **Medical Point of Dispensing (MPOD)**

The City, in partnership with the Los Angeles County Department of Public Health, has established

the Community Center as a Medical Point of Dispensing (MPOD) for the COVID vaccine. This would enable the City to be selected as one of the County's sites.

On February 27, 2021, the U.S. Food and Drug Administration (FDA) issued an emergency use authorization (EUA) for Johnson & Johnson as a third vaccine for prevention of Covid-19. This vaccine is a one shot dose unlike the Pfizer and Moderna that require two shots for full vaccination. Out of an abundance of caution, Johnson & Johnson vaccines were temporarily paused by federal health officials on April 13, 2021 due to a rare and severe type of blood clot found in six cases among more than 7 million people who received the shot. The FDA allowed resumption of the J&J vaccine on April 23, 2021.

### **Vaccine Education**

Residents can view on the City's website the educational Town Hall that was conducted by the City on February 11, 2021 featuring UCLA Health Physician Evelyn Curls, MD, MBA. Also available for viewing is the City's second educational Town Hall conducted on March 25, 2021 in collaboration with CSUDH and Dr. Ana Sophia Lopes.

Individuals who are apprehensive of potential side effects, have a history of allergies or are hesitant for any reason should consult with their physicians regarding their concerns.

### **Vaccines with Emergency Use Authorizations (EUA)**

Vaccines are not fully effective until two weeks after the second dose for Pfizer and Moderna and 2 weeks after the one dose for Johnson and Johnson.

Pfizer-BioNTech	Two dose series separated by 21 days. Indicated ages of 16 years and up.
Moderna	Two dose series separated by 28 days. Indicated ages of 18 years and up.
Johnson & Johnson	One dose. Indicated ages of 18 years and up.

On April 1<sup>st</sup>, eligibility expanded to 50 and over and on April 15<sup>th</sup>, eligibility expanded to 16 and over.

## **V. FISCAL IMPACT**

Staff costs are being incurred by the City for the coordination, surveillance, communication and management of the COVID-19 local emergency, as well as costs for procuring related services and supplies. City costs are either being covered by existing department appropriations or new appropriations from the General Fund. All costs related to the COVID-19 pandemic are being tracked separately by staff who will continue to pursue all available reimbursements for eligible City costs incurred.
