This vacancy exists as a result of an internal promotion within the Division. The Public Works Right of Way Division is responsible for repairs of streets, sidewalks and maintaining the city's fleet of vehicles and equipment; as well as signage, pavement markings and striping, street sweeping, graffiti removal, materials abatement, and solid waste and recycling management. Staff completed the Meet & Confer with AFSCME 809 on July 8, 2021 and both parties are in agreement on the proposed Senior Equipment Mechanic job spec.
