I. SUMMARY

IV. BACKGROUND

On July 20, 2021, the City Council introduced Ordinance No. 21-2116 (Exhibit No. 1 attached) amending Section 5702 (Maintenance of Property) of Chapter 7 (Property Maintenance) of Article V (Sanitation and Health) of the Carson Municipal Code (CMC) to add to the list of enumerated public nuisances that are subject to abatement procedures, to include any condition that results in a violation of the City's Health Code as detailed in CMC 5100 and any condition of a building that qualifies the building as a "substandard building" as defined in Health and Safety Code Section 17920.3.
