Submitted to the Mayor and City Council is the monthly Investment and Cash Report for the City of Carson, former Successor Agency and Carson Housing Authority for the month ending July 31, 2021. Following are the total reserves and cash on hand for the City of Carson and each Carson entity:

City of Carson general fund reserves (Invested assets): \$77,685,600.87

City of Carson general fund cash: \$23,887,242.44
