### SUBJECT:

### CONSIDER AN INFORMATIONAL UPDATE ON CITY PROJECTS (CITY COUNCIL)

#### I. SUMMARY

This report was requested by Mayor Lula Davis-Holmes and transmits an informational update to the City Council regarding various City projects that are currently underway or will begin soon.

An update on citywide Public Works maintenance activities will be presented at the Oct 19, 2021 City Council meeting. This will include updates on concrete projects, asphalt projects, grinding and overlay, slurry seal, and the urban forest program including trees and landscaping.
