RESOLUTION NO. 22-006, A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$6,646,099.94, DEMAND CHECK NUMBERS 160706 THROUGH 161029
