## IV. BACKGROUND

On February 15, 2022 of the Council meeting, the City Council introduced Ordinance No. 22-2201 to adopt an ordinance of the City Council of City of Carson, California to approve an Economic Benefit Agreement with South Bay Carson, LLC.

## V. FISCAL IMPACT

The City of Carson is projected to receive approximately \$40,000,000 in sales tax revenue over the life of the Agreement after computing the maximum subsidy to be paid of up to \$18,000,000 by way of sales tax rebates.
