SUBJECT:

SECOND READING AND ADOPTION OF ORDINANCE 22-2213, "AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, AMENDING SECTION 2611 (EXCEPTIONS TO BIDDING REQUIREMENTS FOR PURCHASES OTHER THAN FOR PUBLIC PROJECTS) OF CHAPTER 6 (PURCHASING SYSTEM) OF ARTICLE II (ADMINISTRATION) OF THE CARSON MUNICIPAL CODE TO AMEND THE COOPERATIVE PURCHASING REGULATIONS" (CITY COUNCIL)

I. <u>SUMMARY</u>

On June 8, 2022 under Item No. 38 of the City Council Agenda, the City Council introduced Ordinance No. 21-2213, for approval of an amendment to the cooperative purchasing regulations of the City's Purchasing Ordinance.

II. <u>RECOMMENDATION</u>

TAKE the following actions:

ADOPT by Second Reading and by title only with further reading waived, ORDINANCE

NO. 22-2213, "AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, AMENDING SECTION 2611 (EXCEPTIONS TO BIDDING REQUIREMENTS FOR PURCHASES OTHER THAN FOR PUBLIC PROJECTS) OF CHAPTER 6 (PURCHASING SYSTEM) OF ARTICLE II (ADMINISTRATION) OF THE CARSON MUNICIPAL CODE TO AMEND THE COOPERATIVE PURCHASING REGULATIONS"

IV. BACKGROUND

On June 8, 2022 of the Council meeting, the City Council introduced Ordinance No. 21-2213 to adopt an ordinance of the City Council of City of Carson, California, for approval of an amendment to the cooperative purchasing regulations of the City's Purchasing Ordinance.

The City Council voted 5-0 to approve the proposed ordinance.

V. FISCAL IMPACT

No immediate impact. The ordinance does provide staff some additional flexibility in the use of Cooperative Services Agencies for the purchase of goods and equipment.
