I. SUMMARY

On March 21, 2022, the City Council adopted the budget for Fiscal Year 2022-2023. Staff is requesting the City Council to approve corrected budget resolutions for Carson Successor Agency (Resolution no.22-05-CSA), Carson Housing Authority (Resolution no. 22-05-CHA) and Gann Appropriation limit (Resolution no. 22-071).

II. RECOMMENDATION

Take the following actions:

1. **WAIVE** further reading and **ADOPT** Resolution No. 22-071, A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON ADOPTING THE ANNUAL APPROPRIATION LIMIT FOR THE FISCAL YEAR 2022-2023 (Exhibit A); **AND**
2. **WAIVE** further reading and ADOPT Resolution No. 22-05-CHA, A RESOLUTION OF THE BOARD OF THE CARSON HOUSING AUTHORITY ADOPTING THE FISCAL YEAR 2022-2023 BUDGET (Exhibit B); **AND**
3. **WAIVE** further reading and **ADOPT** Resolution No 22-05-CSA, A RESOLUTION OF THE BOARD OF THE SUCCESSOR AGENCY TO THE DISSOLVED CARSON REDEVELOPMENT AGENCY ADOPTING THE FISCAL YEAR 2022-2023 BUDGET (Exhibit C)
