## IV. BACKGROUND

To be consistent with other job specifications for City supervisors, the qualifications for Event Services Supervisor are being modified. Staff is recommending that education and experience may be substituted on a year for year basis.

On February 14<sup>th</sup>, staff provided a redline copy of the proposed job description changes to the Carson Professionals and Supervisors Association (CPSA/SEIU 721) bargaining unit for review and concurrence. The unit leadership has replied and is in support of the language addition for the minimum qualifications mentioned earlier. As such, staff is seeking City Council's approval of the revised job description and adoption of Resolution No. 23-044 amending the classification plan accordingly.
