RESOLUTION NO. 19-05-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$20,772.16, DEMAND CHECK NUMBERS HA-001776 THROUGH HA-001778
