RESOLUTION NO. 20-05-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$21,593.81, DEMAND CHECK NUMBERS HA-001815 THROUGH HA-001817
