RESOLUTION NO. 20-11-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$7,403.38, DEMAND CHECK NUMBERS HA-001827 THROUGH HA-001830
