#### RESOLUTION NO. 21-02-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$8,983.50, DEMAND CHECK NUMBERS HA-001842 THROUGH HA-001844
