RESOLUTION NO. 21-03-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$52,746.10, DEMAND CHECK NUMBERS HA-001845 THROUGH HA-001850
