### RESOLUTION NO. 21-04-CSA, A RESOLUTION OF THE CARSON SUCCESSOR AGENCY RATIFYING CLAIMS AND DEMAND IN THE AMOUNT OF \$6,802.50, DEMAND CHECK NUMBER SA-001829
