RESOLUTION NO. 21-08-CSA, A RESOLUTION OF THE CARSON SUCCESSOR AGENCY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$18,123.40, DEMAND CHECK NUMBERS SA-001834 THROUGH SA-001835
