RESOLUTION NO. 21-10-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$28,947.50, DEMAND CHECK NUMBERS HA-001872 THROUGH HA-001875
