RESOLUTION NO. 22-02-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$60,266.71, DEMAND CHECK NUMBERS HA-001889 THROUGH HA-001895
