RESOLUTION NO. 22-04-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$48,663.11, DEMAND CHECK NUMBERS HA-001899 THROUGH HA-001904
