#### RESOLUTION NO. 22-202, A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$3,599,172.18, DEMAND CHECK NUMBERS 151, 164293 THROUGH 164487
