RESOLUTION NO. 22-12-CHA, A RESOLUTION OF THE CARSON HOUSING AUTHORITY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$60,163.38, DEMAND CHECK NUMBERS HA-001918 THROUGH HA-001921
