RESOLUTION NO. 23-04-CSA, A RESOLUTION OF THE CARSON SUCCESSOR AGENCY RATIFYING CLAIMS AND DEMANDS IN THE AMOUNT OF \$23,040.75, DEMAND CHECK NUMBERS SA-001891 THROUGH SA-001892
